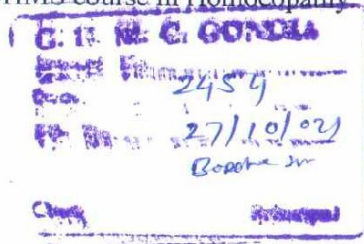
As Central Government by notification, constituted a Commission, to be known as the National Commission for Homoeopathy, to exercise the powers conferred upon, and to perform the functions assigned to it, under NCH Act 2020. As per section 59 (2) of NCH Act, 2020, following has been stated:

“Notwithstanding the repeal of the Homoeopathy Central Council Act 1973, the educational and medical standards, requirements and other provisions of the Homoeopathy Central Council Act, 1973 and the rules and regulations made thereunder shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made thereunder: Provided that anything done or any action taken as regards the educational and medical standards and requirements under the enactment under repeal and the rules and regulations made thereunder shall be deemed to have been done or taken under the corresponding provision of this Act and shall continue in force accordingly unless and until superseded by anything or by any action taken under this Act”.

As per provision in the Act, Medical Assessment and Rating Board for Homoeopathy has been constituted with the mandate to grant permission to the existing and new medical institution of Homoeopathy. Accordingly, it is to inform you that all the relevant documents submitted by your college in Part-1 proforma were examined by the Medical Assessment and Rating Board.

2. On careful consideration of the report, the Medical Assessment and Rating Board has arrived at the following conclusion :-

That the applicant has set up a Homoeopathic Medical College with the component of staff, infrastructure, equipment and instruments and other facilities where as the College has to take certain time bound steps to implement Minimum Standard Requirements of the Homoeopathy College and attached Hospital as prescribed by the National Commission for Homoeopathy for conducting BHMS course in Homoeopathy. The deficiencies observed are as follows:



A. Hospital Staff: Radiologist, Anesthetist, X-ray technician, X-ray attendant, Yoga expert and physiotherapist not provided in the list.

B. Hospital Equipment: Stretcher with trolley, Oxygen cylinder with stand and Diagnostic set (ENT) deficiencies 01 in each not available.

C. Teacher Details:

- i. Dr. Deepali Rajesh Kapoor, Reader, Anatomy (DOB 5.7.74)- passed DHMS in 1994. Joined as lecturer on 6/8/13 in Pandit Jawahar Lal Nehru HMC, Amravati and joined Reader in Gondia HMC on 6/1/19. As per MSR 2013 (8.3.2013) for eligible as lecturer PG degree is required.
- ii. Dr. Manisha V Mishra, Professor, Pathology (MD patho 1995)- Joined as Professor on 1.5.21. No previous teaching experience of lecturer and Reader provided.
- iii. Dr. Vaishali Shende, Reader, Repertory (BHMS 2004)- joined as lecturer on 24.2.13 and promoted reader on 1.5.21. Ten years of lecturer experience not completed. As per MSE 2002.

D. Guest faculties:

- i. Previous teaching experience of Guest faculties in the Department of Practice of Medicine, Homoeopathic Materia Medica, Forensic Medicine and Toxicology, surgery and Obstetrics/Gynecology not provided.
- ii. Affidavit of 1 Guest Reader not provided and Affidavit of one Guest faculty is of Guest Lecturer (Dr. Harsha P. Tembhare) so not eligible.

E. Miscellaneous:

- i. Salary bank statement-not provided
- ii. All lecturers (13) and 01 Reader are getting paid less than Rs.10000/-


3. After considering the provisions of section 12C (1) of Homoeopathy Central Council Act, 1973 and HCC(MSR) Regulations, 2013, **Permission of the Medical Assessment and Rating Board is issued to Gondia Homoeopathic Medical College & Hospital, Gondia 441614, Maharashtra for 50 seats for BHMS course for the academic session 2021-22. The College Principal is directed to fulfill the deficiencies within three months and an affidavit in this regard may be submitted to the Medical Assessment Board within a period of one week.**

4. All admissions in Under Graduate and Post graduate course shall be through NEET only. It is further informed that, minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India quota. The counseling for seats under All India quota shall be conducted by respective counseling Authority of State / UT Government as designated by the Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling Authority of that State / UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted thereunder.

5. The category wise list of selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board as per rules.

6. The college has to comply with the full requirements of HCC (MSR) Regulations, 2013 for conducting the course. All deficiencies observed and mentioned above which affects the performance of the academic Institution, through which College fails to fulfill the statutory requirements, has to be rectified within three months time from the date of issue of this permission letter and the compliance report shall be submitted by the college to Medical Assessment and Rating Board accordingly. Subsequently, the Board shall verify the compliance well in time and may conduct Online/Physical inspection for verification of compliance as per the HCC (MSR) Regulation, 2013 and will consider admissions for the academic year 2022-23.
