PURPOSE OF AGREEMENT

Under the strict supervision of concerned teaching faculty of Gondia Homoeopathic Medical College, a memorandum of understanding is being signed between the Gondia Care Hospital and the GHM College & Hospital for a period of five years, as per the statutory norms prescribed by the Central Council of Homoeopathy.

TERMS OF AGREEMENT
